UNDERGROUND UTILITY INVESTIGATION WORK ON BANK STREET Monday, May 18, 2015

Dear Bank Street Neighborhood Residents:

The Municipality of Princeton is designing improvements to Bank Street for construction in 2015 - 2016. As a part of the design process, we need to more precisely locate the existing underground utilities within the public right of way. In order to do this, the utility companies have been requested to locate their pipelines using colored paint and flags.

On Monday, May 18, Princeton Public Works will be on Bank Street to dig small test pits which will then be surveyed by Princeton Engineering staff to record the horizontal and vertical location of the utilities. To provide adequate maneuvering space for the Public Works vehicles, Princeton Police will be posting "Emergency No Parking" signs on Sunday, May 17, which will be in effect for Monday, May 18th. If an additional day is needed to complete the test pits, the emergency signage will remain in place.

Bank Street will be closed to through traffic while this work is taking place; a barricade will be placed at each end of the roadway. On-street parking will be prohibited between the hours of 7:00 am and 4:00 pm while work is taking place. We request that those who park in the two private parking lots on the south end of Bank Street endeavor to minimize their vehicular trips in and out. If it becomes necessary to leave Bank Street during this work, vehicles from these lots may need to be directed in a wrong-way direction, southerly to Nassau Street.
