***Title 19:23-8 “In the case of candidates to be voted for by the voters of a political party throughout a municipality having a population in excess of 14,000 as ascertained by the last Federal census by at least 50 of such voters.”**

***Title 19:23-8 “Notwithstanding the above provisions, in the case of petitions for candidates to be voted for by the voters of a political party throughout any municipality, ward, or election district, the number of signers of any such petition may be fewer than the minimum number specified above but shall be at least 5% in number of the total vote cast by voters of that political party at the last preceding primary election held for the election of that party’s candidates for the General Assembly.”**

***Title 19:13-5 “The petition shall be signed by legally qualified voters of this State residing within the district or political division in and for which the officer or officers nominated are to be elected, equal in number to at least 2% of the entire vote cast for members of the General Assembly at the last preceding general election, held for the election of all of the members of the General Assembly, in the State, county, district or other political division in and for which the nomination are made; and except that no more than one hundred signatures shall be required to any petition for any officers to be elected.”**
