- A letter granting permission to obtain a permit from the property owner, if the applicant is not the owner of the property (sample attached).
NOTE: a letter of permission is not required if vehicle is parked on a public street pursuant to a "street closing" approval granted by the municipality.
- A copy of an "Inspection Report" for the kitchen hood fire extinguishing system, issued by a Fire Protection Company authorized by the NJ Division of Fire Safety (NJ Permit) to perform such inspections, and issued no more than 6 months prior to the date of the event.
- Copy of a Mobile Food Vendors License issued by the Princeton Health Dept.
- Payment of Type I Permit Fee (\$100) (Cash, Check, or Credit Card).

PLEASE NOTE:

- Failure to be present at the time of inspection will result in a denial of the fire safety permit.
- Failure to comply with all conditions at the time of inspection will result in denial of the fire safety permit.
- The permit may be revoked by the Fire Official or designated representative for failure to comply with the conditions of issuance or any violations of any provisions of the New Jersey Fire Code.
- The use of the Food Truck prior to an inspection shall constitute a violation of the N.J.A.C. 5:70-2.12(b)7.i and the operator shall be subject to a penalty.
